



INSTRUCTIONS FOR SUBMITTING REQUIRED FORMS

FUNERAL PURCHASE AGREEMENT

All funeral providers are required by law to provide consumers with a contract that describes the funeral products and service selected, along with the price of each item. You are choosing *Direct Cremation* at \$895. This price includes all of the following items:

- Transfer of deceased from place of death to our facility, from anywhere in Indiana
- Filing of required paperwork
- Sheltering of deceased in temperature-controlled environment
- A cremation container
- Cremation of the deceased
- A plastic cremation urn
- Return of cremains

Therefore, this \$895 figure has already been posted in the appropriate locations on the contract. If you are adding no upgrades (such as wood or metal cremation urn or "Keepsake" items), all you have to do is sign this contract and forward it to All-State Cremation Service. If you are purchasing an upgraded cremation urn or optional "Keepsake" item, please also enter the item(s) and price(s) under **(C) OTHER ITEMS** on the enclosed Funeral Purchase Agreement. When completed and signed, you may:

Upon receipt of this contract, All-State Cremation Service will, as required by law, add Indiana sales tax to any upgraded product option(s) you may have selected, then total the figures, sign the contract and return a copy to you. (If you have added no product upgrades, the total price will be \$895.)
